Calculating your monthly pre-authorized giving

To help determine the amount of one's monthly contribution, multiply your weekly offering by the 52 weeks in a year, then divide this annual contribution by 12. Examples are provided below for your reference.

Monthly Offertory Weekly Offertory \$10/week (\$520/year) \$43 per month \$20/week (\$1040/year) \$86 per month \$40/week (\$2080/year) \$50/week (\$2600/year) \$100/week (\$5200/year)

How will pre-authorized giving replace my current giving?

If you have envelopes and choose preauthorized giving, you can indicate this on your envelope and place it in the collection each week. Once your envelopes run out, offertory cards are available at the entrance to the church or from the parish office. These can be placed in the offertory in lieu of envelopes as an expression of your contribution. Please note that special collections (i.e. Share Lent, Christmas, etc.) still require the use of special envelopes.

What is pre-authorized giving?

To accomplish the mission entrusted to us by Christ, Our Lady of Guadalupe Parish and St. John's Parish depend entirely on the of our parishioners. generosity Preauthorized giving allows you to give to intentionally and your parish faithfully through scheduled monthly transfers from your bank account. Once a month, your account will be debited an amount you specify. These funds are then deposited directly into the parish's account.

How do I enroll?

First, reflect on all that God has given you, and prayerfully decide how much of this you will return to God through your offertory to the parish. Then fill out the form on the other side of this brochure and attach a void cheque in the space provided. Place the completed form in a sealed envelope into the offertory collection, mail the completed form to the parish, or drop it off in person.
